The full Committee met twice in 2000; prior to the London dinner on 28th January, and at College prior to the Summer Dinner and Keble Association Reunion on 30th June.

Annual General Meeting

The AGM took place at the College on 30th June with the President, Sir David Williams, in the Chair, and some twenty members in attendance.

Mr RN Sainsbury (1959) was elected as President for 2000-2002. Mr GK Buckley whose period in office on the Committee had expired, was re-elected. The Hon Treasurer, Hon Secretary and Hon Membership Secretary were elected for a further year.

Following the AGM, 47 members attended the College Summer Dinner, with 23 bringing their partners as guests. Sir David Williams proposed the health of the College, to which the Warden responded.

Membership

Membership has remained static over the past year. The Association reiterates earlier calls for new members, and for new Committee members.

Financial Report

The full audited accounts are published overleaf. The Keble Association fund showed a surplus of some £11,000 before investment gains, a bigger surplus than expected, due to underspending in some areas and unexpected gifts. The Griffiths Fund made a small surplus due to underspending on the Griffiths Travel Scholarships.

At the end of the year, investments at market value were nearly £22,000 above their 1999 year-end value. However, these “unrealised gains or losses” reflect every movement of the bond and equity markets and can fluctuate considerably in the short term.

It is gratifying to note that nearly £20,000 was made available to students, Old Members and the College by way of grants and loans.

Support for activities in College (£1,500)

In addition to continuing support for music and drama in College with £500 from the Jack Lane Bequest, the Association provided £1,000 of sponsorship for a College Sports Day held at the beginning of Trinity Term.

Hardship Fund (£5,200)

Sixteen grants, ranging from £100 to £600, were made to Junior Members who had encountered unforeseeable financial difficulties during 2000.

General Grants (£300)

Two grants, of £200 and £100, were made during 2000 to support the activities of individual Junior Members.

Vacation Bursaries (£6,000)

Nineteen Bursaries, ranging from £100 to £600, were awarded in 2000 to Junior Members participating for the most part in courses of study and fieldwork, in locations in Europe, Africa and the Far East. The Association thanks the Honorary Treasurer and Miss BM Wood for acting as adjudicators for these awards.

Griffiths Scholarships (£4,500)

Awards for 2000 were made as follows:

- Mr P Anderson £750 to study the long-term importance of sites of strategic and religious importance in Israel.
- Miss E Campbell £1,000 for participating in a refurbishing project at a home for mentally and physically disabled people in Georgia.
- Mr P Schlüter £1,000 to study wild orchid populations in the South Mexican rainforest.
- Miss V Sistenich £1,000 for a medical elective at Wuyi Shan Municipal Hospital, Fujian Province, under the supervision of *Projects Abroad*.
- Miss E Stopford £750 for research into the cultural and mythological traditions of native African society in order to establish their impact on the work of Afro-American writers.

One successful candidate withdrew from the activity for which an award of £1,500 had been made available.

The Association thanks Mr GK Buckley and Dr HR Oliver for acting as adjudicators for these awards.

Graduate Scholarships (£3,324)

In 2000 the Association funded the first year of a two-year scholarship and the second year of another.
