## **Textile Treasure Trove**

Katrina Collison reading Archaeology and Anthropology, was given a Griffiths Memorial Travel Grant to assist her in visiting Laos to study methods and traditions in textiles. She describes some of her experiences.

I learnt about a completely different way of life and attitude to the world. Laos, one of the world's poorest countries, lacks basic plumbing and clean water, yet even in this most remote village it proved obligatory to watch Britney Spears on DVD as we ate our meals!

The town I stayed in had a population of 50,000 and we lodged in the hotel in the area. Within a week we were known as "the group of white people"! In this country which has only been re-opened to visitors in the last five years, I found that the Lao went out of their way to be helpful to tourists and were the friendliest people you could hope to meet.
