The full Committee met twice in 2001; prior to the London dinner on 26th January, and at College prior to the Summer Dinner and Keble Association Reunion on 20th July.

Annual General Meeting

The AGM took place at the College on 20th July with the President, Mr RN Sainsbury, in the Chair, and some twenty members in attendance.

Mr RCR Blackledge, Mr MR Fawcett and Dr HR Oliver were re-elected. The Hon Treasurer, Hon Secretary and Hon Membership Secretary were elected for a further year.

Following the AGM, 56 members attended the College Summer Dinner, with 13 bringing their partners as guests. Mr RN Sainsbury proposed the health of the College, to which the Bursar responded.

Membership

Following a period of static membership, the last year has seen a resurgence in recruiting of new members and increased generosity by many of the existing ones. At present there are 1132 members of College on the roll and about 800 donated last year. The new membership secretary is following up those whose covenants have expired and who may wish to continue their support through the new Gift Aid scheme.

Financial Report

The full audited accounts are published overleaf. It will be seen that total resources expended exceeded incoming resources by nearly £5,200. This overspending was the result of a conscious decision of the Executive Committee to make more money available to offset student hardship and increase donations for travel bursaries and graduate scholarships. It is hoped that this policy, which will be continued in 2002, will raise the awareness of the Association both among the undergraduates and younger graduates, and lead to an increase in the Association's membership.

The value of investments at market price fell from £240,025 to £229,076 between the end of December 2000 and 2001. This unrealised 'loss' of £10,949 was due to the fall in the stock market during 2001 but was significantly smaller in percentage terms than the decline in the stock market index. The value of the Association's funds at 31 December 2001 stood at nearly £307,000.

Support for activities in College (£1,500)

Support for music and drama in College was continued with £1,500 from the Jack Lane Bequest.

Hardship Fund (£7,450)

Twenty grants, ranging from £100 to £500, and a loan of £200, were made to Junior Members who had encountered unforeseeable financial difficulties during 2001.

General Grant (£300)

A grant of £300, was made during 2001 to support the activities of an individual Junior Member.

Vacation Bursaries (£6,200)

Twenty-two Bursaries, ranging from £100 to £500, were awarded in 2001 to Junior Members participating for the most part in courses of study and fieldwork, in locations in Europe, America, Africa and the Far East. The Association thanks the Honorary Treasurer and Miss BM Wood for acting as adjudicators for these awards.

Griffiths Travelling Scholarships (£10,000)

Awards for 2001 were made as follows:

Mr T Bird	£2,000 to study clinical presentation of and immunological responses involved in severe dengue virus infection in Vietnam.
Miss C Corry	£1,000 to gain further experience in paediatrics and skill in dealing with children, working in Port of Spain, Trinidad and Tobago.
Miss K Dykes	£1,500 to practise general medicine and surgery and tropical medicine at Bethesda Hospital, Manado, Sulawesi.
Miss N Green	£2,500 to access material existing only in institutions in North America relating to the metropolitan London book trade around 1400 AD.
Miss L Smith	£3,000 to participate in a 10-month course centred in Pretoria, involving theology study, leadership training and outreach projects.

The Association thanks Mr GK Buckley and Dr HR Oliver for acting as adjudicators for these awards.

Graduate Scholarships (£5,600)

In 2001 the Association funded the second year of a two-year scholarship and the first year of two others.
